



Terms & Conditions

Payment:

Payment to be made directly to our bank account. Alternatively cheques to be made payable to: **Heliotrope Yoga Holidays Ltd.**

We require a £75 non-refundable deposit per person. A booking is not accepted until we have received cleared funds. If you book a share of a twin room and, despite our best efforts to find you a suitable person to share with, none is found by the start of the holiday then we will ask you to pay a single supplement.

Full payment is required four weeks before departure. Provided there is space, bookings can be accepted until the date of departure, but for bookings within four weeks of departure, immediate payment in full is required.

Cancellations:

If you cancel: (a) More than eight weeks before departure, the deposit is forfeited. (b) Less than eight weeks before departure, the following percentage of the total fee is retained or payable, even if the balance remains outstanding: 4 – 8 weeks 40%; 2 - 4 weeks: 60%; 1 - 2 weeks: 75%; less than one week: 100% of holiday fee retained or payable. In many cases, cancellation fees are covered by insurance.

Notification of cancellation of the holiday must be given by email to the following address: info@heliotrope-yoga-holidays.com. Failure to do so immediately may prejudice your entitlement to claim a refund. No refunds can be made once participants are in their place of destination.

Descriptions:
